**PURPOSE/ACTION REQUESTED:**

Consider request of IGH Brewing Company to extend the premise of the existing liquor license sales area to a designated outdoor area September 11, 2021 in conjunction with IGH Days.

**SUMMARY:**

Erin Gerlach has made a request to extend the liquor sales area to the IGH Brewery parking lot in conjunction with IGH Days, for September 11, 2021 from noon to 8:00 pm. There will have a variety of games and activities in addition to live music on Saturday, September 11. A tent will not be set up..

IGH Brewing Company Family Brewya Event will follow all codes required by the Fire Marshal. Beer, wine, liquor, and non-alcoholic beverages will be served. No alcoholic beverages will be consumed outside of the enclosed area, and all service of alcoholic beverages will be completed in strict compliance of the law.

The applicant has provided insurance certification that shows their parking lot is covered in their insurance policy, and the Police Department and Fire Marshal have been notified and has approved the planned event.

Staff is recommending that the application for extended liquor license be approved.
